### 6) Atlantic City Station

Station Configuration
There are 5 tracks in Atlantic City station
Track 5 is on the East Side and Track 1 is on the West Side
The fuel pad is next to tracks 4&5

SI AC 98 Station Tracks

All Tracks south of Atlantic are designated station tracks for the purpose of entraining and detraining passengers. Southward movements must operate at RESTRICTED SPEED not exceeding 5 MPH. Northward movements may operate at RESTRICTED SPEED not exceeding 10 MPH.

### 7) Departing Stations Near An interlocking

When making a passenger station stop and the station stop is in close proximity to an interlocking signal, the train should not proceed from the station until receiving a proceed signal in the interlocking. Conductors should not relay permission to start the train or close the doors until the interlocking signal displays a proceed indication or it is known that the train has received permission to pass a Stop Signal. The following are the affected stations in close proximity to an interlocking.

AC Line: Cherry Hill Pennsauken

## 8) Emergency Protection

SI AC 136

The Atlantic City Rail Line and PATCO right of ways are parallel between MP 6 and Lindenwold MP 11.7. PATCO tracks are equipped with a 600 volt DC third rail electrical power distribution system.

If a train experiences an emergency application of the brakes while operating between Lindenwold and MP 6 the crew must notify the Dispatcher immediately. After the train has stopped, a crewmember must provide flag protection in both directions (one and one half miles) unless it can be determined that no other track Is obstructed or relieved from protecting adjacent track by the Dispatcher.

The Dispatcher must immediately notify the PATCO Control Center of the situation, and where

adjacent track is obstructed, not relieve the crew from providing flag protection unless alternate protection is provided by PATCO.

## 9) Station Sides and High Levels

All stations on the Atlantic City Rail Line are High Level Platforms.

In Atlantic City Terminal doors can be opened on either side of the train depending on which track the train is platformed.

When heading North towards Philadelphia, Absecon, Egg Harbor City and Pennsauken will platform on the right side or east side of the train.

Hammonton, Atco, Lindenwold, Cherry Hill will platform on the left side or west side of the train.

When heading south towards Atlantic City the doors will be opposite of the north bound

travel. 10) Hand Brakes

### SI AC 109

When Securing equipment on Station Tracks south of Atlantic, a minimum of two hand brakes on the south end of the train must be applied.
